Dear Mr. Newlin,

The Stafford Regional Airport Authority (SRAA) desires to exchange its Parcel 38-29 for Parcel 37-66 owned by the Economic Development Authority (EDA), subject to the following conditions:

- As determined by references b. and c., the SRAA parcel was valued at \$740,000 and the EDA parcel was valued at \$720,000. In light of the greater valuation of the SRAA parcel, we propose an even exchange for these parcels, subject to final approval by the Federal Aviation Administration (FAA).
- SRAA will pay for the appraisal costs associated with references b. and c. as well as any subsequent review appraisal required by the FAA, if appropriate.
- SRAA will also pay for all reasonable closing costs and attorneys' fees, pursuant to this exchange.
- If the EDA desires to conduct a one-time harvest of timber on their parcel, it must be expeditiously done at EDA expense and completed before SRAA takes possession of Parcel 37-66.

If the above conditions are acceptable to the EDA, we request that you modify your letter of intent and resubmit to the SRAA for signature. Please contact me if you have any questions.

Mr. Greene and Mr. Farmer updated the EDA on the search for a new FRA president and new marketing efforts. They also re-requested \$70,497 Ms. Maurer again asked about EDA representation on the FRA board. Mr. Farmer informed Ms. Maurer the request was never made to the FRA board. Mr. Owen asked the FRA come back in to the May EDA meeting with a response to the EDA representation on the FRA board and update of the President search.
