Data Center Tax Classification

On March 19 there is a Public Hearing and the BOS is expected to vote to set a different tax classification for Data Centers. Similar to the change we made on Merchant Capital Tax for warehouse\distribution centers over 100,000 square feet, this allows the BOS to set competitive tax rates for these targeted sectors.

Economic Development Activity

Rick Cobert has attended two events this past month and we have at least 2-3 "direct" leads on business investment opportunities and have responded to two additional "leads" provided by FRA this month.

We have also had meetings with a handful of developers for significant projects. In these meetings we are standing by to integrate the value of the EDA to assist in the project.

We have released a "request for expression of interest" for the County property at Quantico Corporate Center.

Quarterly Update(s)

This coming April will represent the first quarterly update on our Economic Development Strategy Implementation Plan (since my arrival). Recall that I proposed to do so as part of our I-Plan. This will be at a CEDC meeting. We hope to have the next quarterly update as part of a joint EDA\BOS meeting (similar to when I presented the I-Plan).
