

STAFFORD COUNTY ECONOMIC DEVELOPMENT AUTHORITY SPECIAL MEETING MINUTES August 28, 2020

A special meeting of The Economic Development Authority ("EDA"), of Stafford County, Virginia was held on August 28, 2020, via conference call.

1. **CALL TO ORDER**

This meeting was held (and advertised) by conference call and called to order by Chairman at 9:05 AM. A quorum was present and accounted for.
